
He is continually seeking out new owners, people who have found success in their lives and are ready to celebrate and enjoy it by immersing themselves in the greatest game in the world. Purchasing Thoroughbreds with Ken McPeek is a gateway to excitement.

As a trainer, McPeek has saddled horses in some of the biggest events in the world, including the Kentucky Derby, Breeders' Cup, Preakness, Royal Ascot and the Belmont Stakes. Among the 107+ Graded Stakes that McPeek has won is the 2002 Belmont Stakes with Sarava. More recently in 2020, he campaigned the Eclipse Award Winning filly, Swiss Skydiver, to triumph in the Preakness.

With expertise in management, as well as equine conformation and racing, McPeek matches the right horses with each owner, working within their budget while maximizing the potential for success.

McPeek developed his reputation by building long-term relationships with clients and continually exceeding their expectations. With meticulous attention to detail and complete knowledge of all facets of the racing game, he has one training principle valued about all else and is always his top priority – he puts horses in positions to win.

MAGDALENA Racing Partnerships

Our philosophy – people should be unafraid. Magdalena partners are co-owners whose expenses including training, farrier, and veterinarian bills are split by the percentage of ownership they have. Race winnings are also distributed by owner percentages. Co-ownership is preferred over an LLC partnership because owners can sell their shares without the legal expenses that are incurred with an LLC partnership.

Kenny McPeek shops for yearlings almost exclusively at the top U.S. yearling auctions – starting with Fasig-Tipton July in Lexington, followed by Saratoga in August; the New York-bred Preferred Yearlings Sale, also at Saratoga; Keeneland September in Lexington; and the Fasig-Tipton October Sale in Lexington. He frequently attends yearlings sales in South America, Ireland, Great Britian, and France.

McPeek is an expert at dissecting pedigree, yet he primarily looks at conformation, targeting the best physical specimens in each sale.

"There's a team of myself,
Dominic Brennan, and Alan
Shell. We look at every horse.
We leave no stone unturned.
We're looking for athletes.
There's a conformation factor – a
horse with a good strong hip and a
great hind leg. And you want a horse
that walks really well," McPeek says.

After his team examines every yearling, McPeek creates a short list and sends it out to prospective clients. The list is simple – catalog (hip) numbers and whether the yearling is a colt or a filly.







McPeek typically has horses on his short list without a particular buyer in mind. Rather, if he believes the horse is being undervalued in the sales ring – he will buy the horse himself, and sell shares as co-ownership under the name Magdalena Racing Partnerships.

Typically, shares are 20-25% of

ownership depending on the cost of the yearling. McPeek retains at least one share for himself as managing partner of each Magdalena horse. Not only does Kenny enjoy the comradery and likes the excitement of watching his own horse race, his ownership ensures partners that he is managing their investments properly.

"Buying into the partnerships is a very good way to diversify your risk

by diversifying the expense," McPeek says. "It's also a really good way to learn the details of the horse industry in the beginning, especially for those a little tentative. You have to have a group of horses to be successful; you can't just do it with one."

"I'm not going to give prospective owners any notion that this game is easy at all," McPeek says. "It's hard. But we're going to give them a fair shake and be forthright with all the details."

Purchasing yearlings and racing with Ken McPeek gives an owner a great chance at success. McPeek, and the bloodstock agents who work for him, are renowned for identifying innate talent others overlook.

While some buyers plunge into the unknown, bidding hundreds of thousands of dollars on a single unproven horse with glittering pedigree credentials, McPeek continually ferrets out not only value but future stars at lower price points. McPeek selected the yearling Curlin at auction for \$57,000, and the colt went on to twice be named Horse of the Year and earn more than \$10.5 million.

While purchasing horses privately and at major U.S. auctions, McPeek also has enhanced his credentials by finding top runners at sales in Ireland, England, Brazil and Argentina.

While McPeek makes himself easily accessible to clients, the McPeek Team supplies racing, post-race, and health updates, as well as guidance arranging the perfect race day experience.

Expenses are billed monthly by our in-house bookkeeper with oversight by an independent CPA. Owners split expenses based on the percentage of ownership without markups. Winnings are distributed as they are received.

AS A Buyer's Agent

As a buyer's agent, Ken McPeek has proven himself to be one of the finest judges of equine potential in the country, repeatedly selecting horses for purchase at moderate prices that go on to spectacular success. No single metric adequately defines the most successful buyers, his formula for evaluating conformation, pedigree, and movement are unrivaled.

McPeek shops for yearlings at all the major sales in the U.S., South America, Ireland, Great Britian, and France. After examining pedigrees, he physically looks at and evalutates every horse standing and walking. Hw creates a short list and sends it out to prospective clients.

If a client is interested in a yearling, they call McPeek directly. He will explain why the horse made his short list. If two clients are interested in the same hip number, he will often put them together as partners. If a client would rather be a sole owner, he identifies what the bidding threshold of each will be.

"The people I do best for just say, 'Find me a good horse,'" McPeek states. "My tendency is to go for horses that will run longer. I want a horse that can run a route of ground. It's my experience that, as 2-year-olds, horses that run longer last longer."

MCPEEK RACING Management

McPeek Racing, founded in 1985, is headquartered at Magdalena Farm in Lexington, Kentucky. Upon purchasing horses at the sales, yearlings are shipped to Magdalena to be assessed. Then in late fall, yearlings are typically sent to our Silverleaf Training Center in Ocala to begin the training process.

When horses are ready to compete, they are sent to one of the McPeek Racing divisions, currently based in Florida, Kentucky, and New York. McPeek selects the track where he expects his horses to achieve their greatest success.

The McPeek Team uses only the highest quality equipment, feed, straw and hay. All medications used in training and racing strictly adhere to industsry rules and regulations. We do not take short cuts.

The operations together provide services for breaking, racing, layup, rehabilitation, sales preparation, breeding and foaling. All entries and nominations are taken care of by McPeek and staff.

"The business is run on the premise of a management style called 'The One-Minute Manager'," McPeek says. "I delegate to the right people and communicate what I want done to ensure every day-to-day detail is handled correctly in a timely manner. Every member of the team knows what to do. There is no chaos."

Clients have comprehensive access to information, guidance and services. When a horse is racing, McPeek's team provides past performances and direction on contacting tracks for reserved seating or a box.

McPeek controls its own vans, so his horses have great flexibility in where and when horses race around the country.

McPeek Racing, with its specialized personnel, is designed for optimally efficient management and care of horses on a daily basis. Through sound business practices, strong relationships, honesty, and good humor, clients know the progress of their horses at all times.





LEXINGTON, KY Magdalena Farm

Magdalena Farm comprises 115 prime acres in the Horse Capitol of the World. It has five barns with 63 stalls, 23 turnout paddocks and a two-mile European-style grass gallop for conditioning. McPeek purchased the property in 2006 and refurbished it.

The farm has an illustrious history, dating back to the Revolutionary War. It has been home to many famous Thoroughbreds, including 1959 Kentucky Derby winner Tomy Lee and Devil Diver, the three-time Horse of the Year.

JULY 27 1780

ORIGINAL LAND DEEDED

Captain David and Mary Hurst Shely for service in the Revolutionary War. Land Warrant #1170 consisting of 1216 acres which included a large "savanah" on the head of a branch of the Elk River.

SHELY FAMILY ERA

Magdalena Weber marries John Shely (b. 6/2/1793), son of David and Mary Shely. Magdalena is considered to be the Matriarch of the land for 40+ years.

THE STALLION STATION

Land developed into a Thoroughbred Farm operating under the name The Stallion Station, one of the first commercial Thoroughbred stallion businesses.

1979

PILLAR STUD

The duPont Family purchases farm. During their ownership, they helped shape the developing Thoroughbred industry.

1994 - 2006

FARM SOLD AND DIVIDED

Farm sold and divided multiple times. Farm and land left uncared for and deteriorated into poor condition.

2006

MAGDALENA FARM

McPeek purchases the land and renames the farm Magdalena in honor of the former Matriarch during the Shely Era.













OCALA, FL Silverleaf Training Center

McPeek purchased Silverleaf Training Center in 2019. Formerly the Padua Farm Training Center, facilities include a six furlong training track, four 24-stall barns, four paddocks, 20 stall/turnout paddocks, six covered round pens, and a five stall quarantine barn.

Silverleaf Training Center is where yearlings are shipped in late fall to begin their training process of breaking, racing, and gate training. Improvements were made by McPeek to directly benefit two-year-olds in training such as grading the track, adding a fully operational starting gate, new fencing, and new paddocks.

"Silverleaf is a great addition. It has everything you want in a training center" McPeek states. "The years prior we had dozens of horses at each of six training divisions. We had good

people in all spots and we did fine. Yet logistically it was hard. This will make us stronger."
